



## **Scholarship Funds Guidelines**

**Purpose:** The Scholarship Funds (3) are intended to assist people with financial scholarships to aid those with bleeding disorders and, in the case of the Jill Wayne scholarship, also the immediate family in fulfilling their greatest potential. These educational scholarships are for persons residing in the CCBDF service area.

### **Guidelines**

- The Chairperson shall ensure that applications will be distributed to eligible candidates during the month of February with a requirement that the completed applications be returned to the committee by March 31. Applications will be reviewed by the Client Services Committee, with recommendations being forwarded to the general board for approval at the April board meeting. Awards will be given to the recipients at the Award Dinner on the first Sunday in May. A different timeline can be established if approved by a majority vote of the Client Services Committee.
- The maximum award per year will be \$2000 for a full academic year for a full academic load of 24 units for two semesters or its equivalent.
- Applicants must have a cumulative grade point average of 2.0 and attend an accredited institution.
- Full time enrollment in a vocational school will qualify and be treated the same as attendance at college. Unit amounts may vary from college units.
- The maximum award per person will be \$8000 unless the entire Client Services Committee approves an exception. The Board can also vote to increase the awards if all aware recipients for that year are treated equally.
- If special donations are made to a particular Scholarship Fund, then they shall be honored and take priority over the general guidelines.

### **WILL AND GLORIA CURTIS SCHOLARSHIP FUND:**

- Eligible applicants must have a bleeding disorder and reside in the area served by CCBDF.
- The general guidelines above apply.

### **JIM CAREY SCHOLARSHIP FUND:**

- This fund was established by the CCBDF Board of Directors to honor one of the founders of CCBDF and his contributions to the bleeding disorder community.
- Eligible applicants must have a parent with a bleeding disorder and reside in the area served by CCBDF.
- The general guidelines above apply.
